House Rules FM4 Frequency Festival

General

Without exception, the house rules, the safety instructions and the general information of the organizer need to be followed; These arrangements can also be specified or adapted by security personnel of the organizer and are also to be followed without exception.

At open-air events, there may be a disruption of performances, area evacuation, cell vacations, etc.. These measures are announced by loudspeaker announcements and by the security service staff, if necessary online and through recordings on video walls. The order of the security service staff is uncontradicted in this case!

In case of danger from severe weather with storm, lightning strike, etc. The visitors should seek shelter in their cars on their own responsibility and provide visitors with no cars with any available seats (through the hazard warning lights)!

Furthermore, in this case it is urgent to keep a distance from trees!

The camping of the frequency festival is laying along the river Traisen, the swimming in said river happens at the own!

Camping on the embankment or in the bank area of the Traisen is strictly prohibited for safety reasons!

Entering the weir system of the Traisen (and the weirs of nearby streams) is strictly prohibited for security reasons!

Large gas cartridges, gas cylinders and various flammable liquids as well as drones and other flying objects are strictly forbidden on the whole area (parking lot, camping site, caravan site, nuclear area, etc.)!

The brands of the event and the local framework of the cooperation advertising partners are protected. The use of these signs for own advertising points (influencer, blogger, etc.) is unlawful and unlawful under competition law; all cases also exist by means of provisional availabilities. The organizer is certainly interested in another partnership, namely in the conversation - but this against any violation of his rights or the rights of his cooperation partners. On site, the organizer will enforce their rights against unwanted festival brand uses also with the help of the house right.

A. Parking Regulations

1. Scope

The parking regulations apply to the parking lot at the FM4 Frequency Festival.

Access to the car park is only granted for festival visitors with a valid FM4 Frequency ticket and only during opening hours of the campsite and parking lot.

By entering the parking site, the visitor unconditionally agrees to the parking regulations as well as all relevant statutory provisions and orders imposed by the public authorities.

Any instructions given by the security personnel must be followed at all times. The regulations of the StVO (Road Traffic Act) apply at the parking site.

2. Prohibitions

Parking space assignments must be followed. Parking a vehicle on the traffic roads between the parking lots is prohibited.

Camping, pitching a tent or setting up a night camp is strictly prohibited on the parking site.

Littering or dumping waste on the parking area is strictly prohibited.

3. Responsibilities

The organizer/promoter is not liable for personal injury or damage to personal property that may occur at the parking site.

The organizer/promoter is not liable for any objects left, lost, stolen and placed at the parking site.

B. Camping-, Green Camping-, Tent Hotel-, VIP-, Glamping, Caravan Regulations

1. Scope

The camping regulations apply to the whole campsite (for example normal camping, green camping, VIP camping, tent hotel, caravan camping, glamping) at the FM4 Frequency Festival. The campsite and caravan camping area (+ all further camping options) may be used during opening hours and only by festival visitors holding a valid FM4 Frequency ticket. Access to the caravancamping area is only granted with a valid Caravan Ticket. For early camping visitors will have to pay an additional fee to enter the camping area. By entering the camping areas, the visitor agrees to the camping and caravan regulations as well as all relevant statutory provisions and orders imposed by the public authorities. Any instructions given by the security personnel must be followed at all times.

Daily visitors have no camping option!

We do not tolerate any kind of harassment or threats towards other visitors.

By entering the camping and caravan site, the visitor agrees to security checks and searches of any kind of luggage (bags, backpacks, etc.). Visitors also agree to be subject of a possible body search, if considered necessary.

2. Prohibitions

It is strictly prohibited to start a campfire or set off an open fire. The usage of gas cookers or any other gas equipment is prohibited. Visitors are only allowed to use barbecue equipment at the public BBQ area.

Additionally, following items are completely banned and must not be used or brought to the area:

- gas cartridges and fuels (petrol, Diesel, fuel oil)
- inflammable objects (e.g. unnecessary furniture)
- any kind of fireworks
- weapons or weapon-like items

It is prohibited to dig holes in the ground.

Swimming in the river "Traisen" is on the visitors own risk.

Camping near the river bank is strictly forbidden.

It is strictly forbidden to access the weir and all its side buildings.

It is strictly prohibited to obstruct roads (main roads and sideways) as well as emergency exits with tents or other objects.

Driving motor vehicles or any kind of other vehicles is prohibited at the camping site. Only vehicles of emergency services, security services and the organizer/promoter are permitted.

Only one party tent (marquee) is permitted per caravan or camper. It must cover at least 50% of your sleeping tent. For health and safety reasons, sleeping inside the party tent is not allowed. Tents next to cars or vehicles are not permitted either.

Vehicles longer than 11 meters and exceeding a weight of 3,5t are not allowed at the caravan camping area.

Please consider our strict glass and bulky waste prohibition on the camping and caravan area. Beer crates, tables and benches are also prohibited.

It is strictly prohibited to damage or modify (knock over, set fire to, etc.) any kind of equipment provided by the promoter such as shower facilities, chemical toilets, etc.

It is strictly prohibited to climb structures (such as roofs, towers, containers, etc.) at the camping and caravan area.

The use of sharp or bulky items is not permitted at the camping and caravan area.

Any damages to the fence as well as climbing or knocking it over is strictly

prohibited.

Visitors are not allowed to reserve or occupy camping space for other visitors who do not need a spot immediately.

The possession or use of drugs is prohibited.

It is not allowed to bring pets to the camping or caravan area.

It is not allowed to reserve camping spots.

Furthermore the following things are forbidden:

- 1. Weapons or dangerous objects, which can be used as weapons
- 2. Glass containers, glass bottles
- 3. Pyrotechnic articles, e.g. fireworks, Bengal light, etc.
- 4. Chain belts, studded straps and studded belts (conical studs)
- 5. Flyers, which are not permitted by the organizer/promoter
- 6. Drugs
- 7. Pets
- 8. Drones and similar flying objects
- 9. Big and loud stereo equipment or PA systems, especially from 10:00 pm to 08:00 am

3. Responsibilities

The organizer/promoter is not liable for any objects left, lost, stolen or placed at the whole camping area.

The organizer/promoter is only liable in cases of intent or gross negligence and cannot be held liable for any personal injury or property damage beyond his sphere of influence.

Furthermore, the organizer/promoter cannot be held liable for any personal injury or property damage related to visitors who still remain at the campsite or re-enter it after the official end of the festival or the closing of the camping area.

The campsite regulations apply as soon as the setup of the Frequency starts and can be changed at any time. The rules revoke when deconstruction is finished.

Any violation of the camping regulations will lead to an immediate festival ban and loss of admission to the Frequency. Tickets will not be refunded if ejected from the festival for any violation of our policy.

C Regulations Stage/Core Areas

1. Scope

These Regulations apply to the stage area (so-called core area, including the party area) at the FM4 Frequency Festival.

Access to the core area is only granted to festival visitors holding a valid Frequency ticket and only during opening hours. By entering the core area, the visitor agrees to the camping and caravan regulations as well as all relevant statutory provisions and orders imposed by the public authorities. Any instructions given by the security personnel must be followed at all times.

Any kind of harassment, threatening or abusive towards other visitors is strictly prohibited and will not be tolerated.

By entering the core area, the visitor agrees to security checks and searches of any kind of luggage (bags, backpacks, etc.). If deemed necessary with the help of technical instruments (metal detectors, etc.) Visitors also agree to be subject of a possible body search, if considered necessary.

The visitor consents to being filmed and photographed at any time during his presence at the festival or camping area. The visitor also gives permission to the unpaid use of this material and that it can be used and transmitted anywhere and anytime through any kind of technical means and as promotional material.

Access to the first stage wave-breaker is supervised and regulated by the security personnel at the entrances. In order to prevent overcrowding, the entrance will be closed and access will no longer be permitted after the area has reached its maximum capacity. In this case, visitors are obligated to clear the entrance area in front of the gates and follow the instructions given by the security personnel.

2. Prohibitions

The following items are strictly prohibited and must not be brought to the festival area:

- Weapons or dangerous objects, which can be used as weapons
- Glass containers, glass bottles, cans, plastic bottles & plastic tanks and hardshell packaging
- Bulky objects, e.g. stools, chairs, boxes
- Poles, umbrellas, torches, sticks (e.g. selfie-sticks)
- Pyrotechnic articles, e.g. fireworks, Bengal light, etc.
- Chain belts, studded straps and studded belts (conical studs)
- Visual and audio recording devices
- Flyers, which are not permitted by the organizer/promoter
- Drugs
- Pets
- Drones and similar flying objects

It is also prohibited to:

- 1. throw any kind of objects
- 2. bring along food
- 3. stage-dive and crowd-surf
- 4. push at the festival site or at the entrances and exits to the stage barriers or the general entrances and exits
- 5. block escape routes and emergency exits
- 6. ignite objects (except tobacco products)
- to urinate and defecate outside the toilets
 damage and alter (knock over, set a fire to, etc.) any kind of equipment provided by
 the promoter such as shower facilities, chemical toilettes, etc.
- 8. climb structures (e.g. towers, roofs of containers and similar) at the camping and caravan area
- 9. damage the fence as well as to climb or knock it over
- 10. enter the stage and backstage areas

3. Responsibilities

The organizer/promoter is not liable for any objects left, lost, stolen or placed at the festival area.

Attending the festival is at one's own risk. The organizer/promoter is not liable for personal injury or property damage.

The organizer/promoter cannot be held liable for any hearing or health damage caused by a high noise level.

The organizer/promoter is only liable in cases of intent or gross negligence and cannot be held liable for any personal injury or property damage beyond his sphere of influence.

Furthermore, the organizer/promoter cannot be held liable for any personal injury or property damage related to visitors who still remain at the festival area or re-enter it after the official end of the festival or the closing of the core area.

The festival regulations apply as soon as the setup of the FM4 Frequency starts and can be changed at any time. The rules revoke after deconstruction is done.

Any violation of the festival regulations will lead to an immediate festival ban and loss of admission to the FM4 Frequency Festival. Tickets will not be refunded if ejected from the festival for any violation of our policy.
